## Laborers, Freight, Stock & Material Movers Job Description:

• Manually move freight, stock or other materials

## Entry Level Requirements:

- High school diploma is preferred; must be able perform physical tasks (lift, carry, bend)
- Employers typically provide training on equipment usage and best safety practices

#### Forklift Operator Job Description:

- Responsible for operating and managing industrial trucks to load and unload materials
   Career Advancement Requirements:
  - OSHA <u>require</u>s all forklift operators be trained and evaluated every 3 years
  - Forklift training must include formal classroom training AND practical hands-on training
  - List of Forklift training schools offering certification in New Jersey are listed here

### Teacher Assistant Job Description:

- <u>Assist</u> in the teaching of academic and social skills to students at any and all school levels
   Entry Level <u>Requirements</u>:
  - Obtain an Associate's degree or higher OR complete two years of study at an institution of higher education OR pass a formal assessment that tests knowledge & ability to assist in math, reading and writing
  - New Jersey Department of Education addresses <u>frequently asked questions</u> regarding teacher assistant role

#### **Elementary School Teacher Job Description:**

• <u>Teach</u> academic and social skills to students at the elementary school level

#### Career Advancement Requirements:

- Obtain Bachelor's degree with minimum of 60 liberal arts credits; minimum GPA is 3.0
- Pass Praxis exams Core Academic Skills for Educators along with specific subject exams
- Complete teacher preparation program for <u>Certificate of Eligibility with Advanced Standing</u>
   (<u>CEAS</u>), which provides better job opportunities; approved NJ programs listed <u>here</u>

## Registered Nurse Job Description:

• Assess patient health problems and needs, develop and administer nursing care

### Entry Level <u>Requirements</u>:

- <u>Complete</u> a state-approved nursing program
- Pass the National Council Licensure Examination-Registered Nurse (NCLEX-RN) exam (\$200)

#### Nurse Practitioner Job Description:

• <u>Diagnose</u> and treat patients independently or as part of a healthcare team

#### **Career Advancement Requirements:**

- Earn a graduate degree in a chosen nursing specialization
- Become <u>nationally certified</u> by an accredited agency
- Apply for license

# Immigration in New Jersey

The following are facts about the <u>immigrant community in New Jersey:</u>

- Immigrants comprise 23% of the state population and 29% of the New Jersey labor force
- Top industries of immigrant employment:
  - Health Care and Social Assistance, 212,892 workers
  - Manufacturing, 154,555 workers
  - o Retail Trade, 148,613 workers
  - Professional, Scientific, and Technical Services, 141,012 workers
  - Construction, 108,195 workers
- 136,186 immigrant business owners account for 33% of all self-employed New Jersey residents

- 59% of immigrants in New Jersey are naturalized and another 22% are undocumented
- Top foreign-born countries of origin:
  - o India, 13%
  - o Dominican Republic, 10%
  - o Mexico, 5%
  - o Ecuador, 4%
  - o Philippines, 4%
- 18% of native-born New Jerseyans are children of an immigrant
- Educational attainment of foreign born adults in New Jersey:
  - High School diploma or less 42 %
  - More than HS diploma, less than Bachelor's degree 18%
  - Bachelor's degree or higher 40%
    - Share of <u>Brain Waste</u>\* 21%

<sup>\*</sup> Share of <u>immigrant professionals</u>, who are unemployed, employed at poverty-level wages in High School diploma or less jobs, or significantly underemployed in more than HS diploma, less than Bachelor's degree jobs
