• Supervise and coordinate activities of retail sales workers in a department

Career Advancement Requirements:

• High School diploma or GED typically required

- Accounting training programs in New Mexico listed <u>here</u>
- On-the-job training

Accountants & Auditors Job Description:

- <u>Analyze</u> financial information and prepare financial reports on activities in an organization Career Advancement Requirements:
 - A bachelor's degree and at least 1 year of accounting experience
 - Pass the <u>CPA</u> exam (<u>Approx. \$900 with \$180 application fee</u>)
 - Pass the <u>AICPA</u> ethics exam with minimum score of 90 (\$189-\$245)
 - The New Mexico Public Accountancy Board has <u>no</u> requirements for U.S. citizenship or state residency, but social security number is required

Registered Nurse Job Description:

• Assess patient health problems and needs, develop and administer nursing care

Entry Level Requirements:

- <u>Complete</u> an accredited nursing program in New Mexico
- Pass the National Council Licensure Examination-Registered Nurse (NCLEX-RN) exam (\$200)

Nurse Practitioner Job Description:

• <u>Diagnose</u> and treat patients independently or as part of a healthcare team

Career Advancement Requirements:

- Earn a graduate degree in a chosen nursing specialization
- Become <u>nationally certified</u> by an accredited agency; renewal every 2 years

Immigration in New Mexico

The following are facts about the <u>immigrant community in New Mexico</u>:

- Immigrants comprise 9% of the state population and 12% of the New Mexico labor force
- Top industries of immigrant employment:
 - Construction, 17,946 workers
 - o Accommodation and Food Services, 17,588 workers
 - Health Care and Social Assistance, 12,618 workers
 - o Retail Trade, 10,135 workers
 - Educational Services, 9,929 workers
- 18,935 immigrant business owners account for 17% of all self-employed New Mexico residents

- 41% of immigrants in New Mexico are naturalized and another 29% are undocumented
- Top foreign-born countries of origin:
 - o Mexico, 72%
 - o The Philippines, 3%
 - o India, 2%
 - o Germany, 1%
 - o Cuba, 1%
- 11% of native-born New Mexicans are children of an immigrant
- Educational attainment of foreign-born adults in New Mexico:
 - High School diploma or less 64%
 - More than HS diploma, less than Bachelor's degree 18%
 - Bachelor's degree or higher 18%
 - Share of <u>Brain Waste</u>* 15%

^{*} Share of <u>immigrant professionals</u>, who are unemployed, employed at poverty-level wages in High School diploma or less jobs, or significantly underemployed in more than HS diploma, less than Bachelor's degree jobs
