# **Corporate Roundtable for the New American Workforce**

Co-chaired by Chobani and Walmart, the Roundtable represents a diverse group of industries working together to advance an advocacy agenda and provide the foundation for a movement to implement corporate best practices for their foreign-born workers to fulfill their potential and contribute to our nation's economic success.

#### **THE NEED:**

Immigrants, refugees, and their families contribute to America's economic strength and vitality. The Bureau of Labor Statistics found, "foreign-born workers represented 17.4% of the U.S. labor force in 2019, up from 14.8% in 2005."

Across different sectors, the foreign-born workforce plays a significant role, so it is vital that the Roundtable reflect a diversity of businesses. Immigrants represent 17% of the U.S. workforce, comprising 73% of the agriculture sector, 19% manufacturing, 35% building maintenance, 28% in highly-skilled healthcare, 20% in logistics and 14% in retail.

### **THE GOAL:**

Convene the nation's leading corporations and business associations to advance strategies that integrate new Americans into the U.S. labor market so all have the opportunity to thrive.

The Roundtable executes a short and long-term approach, engaging in the current policy debates and advancing a combination of research, communications and services that promote the value of the new American workforce.

- Immigrants working together with U.S.-born citizens — are fundamental to building a more prosperous country that lives up to the ethos of the American dream.
- The successful integration of newcomers into our workforce and communities is essential to America's future.
